


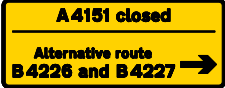















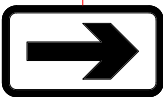

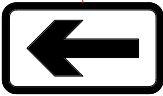


6am to 11.59pm - Market Street from the junction of Victoria Street to High Street
