- (1) Your employment, office, trade, profession or vocation carried on by you or those persons referred to above for profit or gain
- (2) Any payment or provisions of any other financial benefit (other than from the Council) made or provided within the last 12 months in respect of expenses you have incurred in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992
- (3) The name of any person or body in which you or a person referred to above has a beneficial interest in securities of that body where:
  - (a) that body to your knowledge has a place of business or land in the Council's area; and
  - (b) either-
    - (i) the total nominal value of the securities exceeds £25,000 or 1/100<sup>th</sup> of the total issued share capital of that body; or
    - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or a person referred to above as a beneficial interest which exceeds 1/100<sup>th</sup> of the total issued share capital of that class
- (4) A description of any contract for goods, services or works made between the Council and you or the persons referred to above (or a body in which you or they have a beneficial interest) and which has not been fully discharged
- (5) Any land in the Council's area in which you have a beneficial interest. You need to specify any property including your home and any land or buildings from which you receive rent
- (6) Any tenancy where, to your knowledge, the landlord is the Council and the tenant is a body in which you or a person referred to above has a beneficial interest
- (7) Any land in the Council's area for which you or the persons referred to above have a licence (alone or jointly with others) to occupy for a month or longer
- (8) Any body to which you are appointed or nominated to by the Council
- (9) Any body, of which you are a member, which (i) exercises functions of a public nature; (ii) is directed to charitable purposes; or (iii) is one of whose principal purposes includes the influencing of public opinion or policy (including any political party or trade union)
- (10) Any person from who you have received a gift or hospitality with an estimated value of at least £50.
